1. Contractors may bid for one (1) or more component of this request for proposals.
2. Contractor shall provide quotes with details specifications in US standards.
3. Contractor shall deliver the quantities listed.
4. Contractor shall demonstrate capacity to maintain inventory locally and to maintain stock-outs at minimum.
5. Should a product included in the Agreement become discontinued and unavailable to Contractor after the Agreement award, Contractor shall immediately notify PAN Fund. Contractor may propose a substitute replacement product, if available. PAN Fund may approve such a substitution with an amendment to the Agreement. Any substituted product(s) must meet or exceed the specifications/quality of the contracted product. Pricing of substituted product(s) may not exceed the cost of the contracted product(s). Samples may be required for PAN Fund to validate the quality of product. Samples shall be furnished to the PAN Fund at no expense.
6. Upon delivery of product, if the product is defective or damaged the products will be returned to the Contractor at no expense to the PAN Fund. Products shall be delivered to Palau Protected Areas Network Fund Office located at the Palau International Coral Reef Center, Malakal Dock.
